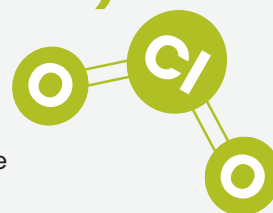

This causes a molecular imbalance leading to the microorganism's death.

This mode of action makes ClO₂ highly efficacious, even at low concentrations.
